Thank you for your request for information regarding ACRO which has now been considered.

Applicant Question:

Further to response 003/16 Notification out of EU, I would be grateful to receive a breakdown by listed Country of the total notifications during 2015 which have a London Court entered.

NPCC Response:

The NPCC does hold information captured by your request.

As per your response 003/16, you have been provided with the number of notifications they receive from the Police National Computer (PNC) when a record of an EU National is updated with a new conviction. Notifications are also generated when existing convictions are updated. These notifications are then sent to the EU Member State of nationality by the United Kingdom Central Authority for the Exchange of Criminal Records (UCKA-ECR).

The destination state is determined by the nationality as entered on the PNC record. This nationality can be self declared by the individual and therefore may not always be correct or truthful. If a nationality is not entered on the PNC record the UKCA-ECR will not receive a notification from the PNC.

To be clear, this relates to the number of notifications messages sent by the UKCA-ECR to Member States for 2015, it is not the number of arrests and/or convictions.

ACRO also holds information for notification messages sent in 2015 which are listed as being from a London Court. For your convenience, I also include the list of 119 London Courts that were searched.
